IN ADDITION, ANY PERSON WHO USES REGISTRY INFORMATION TO THREATEN TO COMMIT A CRIME MAY BE PUNISHED BY A FINE OF NOT MORE THAN ONE THOUSAND DOLLARS (\$1000.00) OR BY IMPRISONMENT FOR NOT MORE THAN SIX (6) MONTHS (**M.G.L. C 275, S 4**).
